

Sometimes you have to think the unthinkable, expect the unexpected to succeed.

Scenario 9: Severe Weather Warning

The National Weather Service has issued a tornado warning for your area.

Discussion Questions:

- 1. How would you react?
- Do you know the difference between a watch and a warning?
- 3. Are there tornado shelters identified within the facility?

Scenario 10: Severe Weather

It's 3:03 PM and a severe storm has just rolled through your community. School-aged kids were being dismissed from school when the eye of the storm went through town.

Discussion Questions:

- 1. How would you react?
- 2. Many employees have school-aged kids, has your company encouraged family preparedness initiatives?
- 3. Do employees have a family communication plan?
- 4. Have you identified safe areas for your family members to go during this situation?


